



Partnering Workshops

The Texas Department of Transportation (TxDOT) and the Associated General Contractors (AGC) of Texas cordially invite all contractors to attend one of several Statewide Partnering Workshops that will be held in the coming months. We hope you will take advantage of this opportunity.

What Is It?

This is an opportunity to sit down with local TxDOT officials, prime contractors, and subcontractors to learn about the new partnering special provisions.

Who Should Attend?

All contractors are invited to attend this event. Topics will be directed toward prime contractors but subcontractors are welcome to attend to become familiar with the new partnering procedures.

For industry, contractors, superintendents, project managers, and CEOs should attend. For TxDOT, chief inspectors, Area Engineers, Directors of Construction, and District Engineers should attend. This three hour workshop is designed for those involved in the construction phase of TxDOT projects.

What Topics Will Be Covered?

The objective of these workshops is to bring all current and future construction project personnel up to speed with the department's new partnering initiative. Topics covered will include the forthcoming modifications to the specifications, step by step examples of the implementation process for partnering, and answers to any questions or concerns you may have regarding the new requirements.

Is There A Charge for this Event?

This event is free of charge for AGC of Texas members and TxDOT employees. All other attendees will be charged a registration fee of \$50. Lunch will be served at each workshop.
